In pursuance to the resolution of the Board of Paradip Port Authority vide No. 164/2024-25 dtd 30.01.2025 it has been approved for the following ;

- a) i) To rescind the contract of M/s DNC Infrastructure Pvt. Ltd, Hyderabad issued vide Work Order No.CE/R&B/Accts-72/19 (Pt-III)/162 dtd.07.06.2024 for the work 'Construction of 350 qtrs. for Port employees and also to facilitate and reserve land for the future expansion of the Port in Nuabazar area - 1st Phase (91 qtrs)' since their reply to 14 days notice is not satisfactory and acceptable to Paradip Port.
- ii) To execute the balance work at the risk & cost of the contractor by inviting fresh e-tender.
- b) To debar the contractor M/s DNC Infrastructure pvt ltd, Hyderabad for a period of 03 (three) years from participating in future tenders of PPA.
- c) For legal action against the firm for which an FIR has been lodged with EOW (Economic Offence wing) , Bhubaneswar
- d) Full mobilization advance with interest amounting to Rs 3,45,10,973/- has been recovered from the R/A bill of the contractor .
- e) MSME will be informed for necessary action at their end.
- f) PMC contract is hereby foreclosed simultaneously with termination of this contract.
